



# **A G R E E M E N T**

## **ON COOPERATION**

### **BETWEEN**

**EAST EUROPEAN UNIVERSITY RAUF ABLYAZOV (UKRAINE) AND  
UNIVERSITY OF SECURITY MANAGEMENT IN KOŠICE (SLOVAKIA)**

#### **I. General**

This Memorandum of Cooperation (hereafter - Memorandum) defines relations and areas of cooperation between *UNIVERSITY OF SECURITY MANAGEMENT IN KOŠICE (SLOVAKIA)* represented by the *RECTOR, DR.H.C. ASSOC. PROF. PETER LOŠONCZI, PH.D., MBA, LL.M.*, acting under its existing powers and *EAST EUROPEAN UNIVERSITY RAUF ABLYAZOV (UKRAINE)* in the person of *RECTOR, PROFESSOR IIA CHUDAIEVA*, acting under the powers available to it, hereinafter referred to as the "Parties".

Parties conclude this Memorandum of mutually beneficial cooperation in the interests of science and education, implementation training programs and research projects, use of the results of cooperation to meet the needs of society and strengthening the international image of both countries.

The Parties have agreed on the following:

#### **II. The subject of the Memorandum**

The subject of the memorandum is a scientific and educational cooperation between the Parties on an equal and mutually beneficial basis.

Cooperation aimed at developing research, education, information and communication, analytical, consultative international activities.

#### **III. Areas of cooperation**

In order to implement this Memorandum, the Parties determine the following areas of cooperation:

- cooperation and development linkages through joint programs and projects with government organizations, scientific institutions and educational institutions;
- development and joint research projects of mutual interest, including the administrative, social and human sciences; ensure the efficiency of their development and implementation;
- the exchange of experiences, knowledge and information accumulated by Parties in their respective fields, through joint conferences, seminars, symposiums, "round tables" and other communication activities, exhibitions with the participation scientists from other universities, research institutions , etc;
- promotion of scientific schools; formation of temporary creative teams for research, training; public presentation of research results, monographs, textbooks, etc.;
- preparation, publication and dissemination of scientific literature, including reference; exchange of scientific publications;
- the organization of education, training, and professional development of students, teaching staff, specialists of local government and regional administration, representatives of non-profit and public sector organizations; promote the training of foreign students in Ukraine;
- the organization of scientific advice and training for students, teachers, doctorates;
- the exchange of experts in their respective fields of mutual interest;
- the cooperation with international organizations for grants;
- any other cooperation agreed by the Parties.

#### **IV. Final provisions**

The Parties are considering this Memorandum as a declaration of intent that does not lead to legal and financial commitments in joint activities.

Any actions under this Memorandum should not limit any powers and rights of the Parties.

Disputes and disagreements between the Parties on matters relating to the scope of this Memorandum will be resolved through negotiations or consultations between the Parties.

This Memorandum may be supplemented and partially modified by written agreement of both Parties.

This Memorandum will enter into force upon signature by authorized representatives of both Parties. The validity of the Memorandum is one year. Automatically extend the Memorandum for each next one-year period if any of the Parties does not declare of their unwillingness to extend the Memorandum no later than six months before it expires.

Memorandum may be terminated earlier by mutual agreement of both Parties, if one Party declares in writing no later than six months before the intended date of termination of this Memorandum.

The Parties undertake implementation of all existing obligations previously initiated cooperation activities identified under this Memorandum.
